RESOLUTION

No. 431 dated August 1, 2014

On Approval of Regulations on Free Economic Zones Bishkek, Karakol, Leilek, Maimak and Naryn

To create favorable conditions for attracting foreign investment and regional development, in accordance with Article 9 of the Law of the Kyrgyz Republic "On Free Economic Zones in the Kyrgyz Republic", the Government of the Kyrgyz Republic hereby resolves:
